### **History of the Methodist Home for Children System**

The Methodist Home for Children was established in 1879 as a home for children orphaned by the Civil War, with the property generously donated by a local philanthropist, Colonel Joseph Bennett. While the organization has always received support from the Methodist Church's vast network, it is not officially affiliated with the Church and has always served children of all faiths. Over the past 144 years, as the needs of the community have changed, The Methodist Home for Children has undergone restructuring and renaming, and evolved its programs, but remains true to its founding commitment to children and their families.

Methodist Services and The Methodist Home for Children Foundation were established as supportive institutions to the Methodist Home for Children, each playing a distinct role to oversee the organization's significant physical assets and residential properties; manage its \$36 million endowment; and administer its diversity of programs. When conducting this strategic planning process, the Methodist Home for Children and Methodist Services were being considered for merger into one body and would remain a separate entity from the Foundation. The collective organizations are referred to as the Methodist Home for Children System (MHCS).



### **Vision, Mission & Programs**

#### **Our Vision**

MHCS serves as a lifeline for those grappling with adversity, extending vital support, resources, and pathways to transformation. MHCS's high-quality services empower clients to surmount obstacles and nurture self-sufficiency. Their exemplary programs also facilitate connections for clients within the community, leading to increased support, partnerships and resources.

#### **Our Mission**

MHCS provides life-enriching services to children, adults, and families as they face the challenges of limited resources, increased poverty and homelessness, disability, and inequities in education and behavioral health services.

### **Our Programs**

Philadelphia has one of the highest poverty rates in the country, affected by structural racism, gun violence and an increasing wealth gap. Like other areas of the United States, there is an increasing disparity between housing costs and wages. Philadelphia's children have huge challenges obtaining a quality education, with Philadelphia ranked fourth from the bottom in fourth-grade math and reading out of 26 big city districts in a national assessment. All of these issues contribute to poor education and employment outcomes, as well as homelessness whereby in 2022, on any given night almost 4,500 unhoused individuals could be found on the streets of Philadelphia.



Another major issue impacting all communities, but especially low-income families and individuals, including within Philadelphia, is the nationwide mental health crisis and the prohibitive cost of mental health services. According to the National Alliance on Mental Illness and the National Council for Mental Wellbeing, 1 in 5 Americans have a mental health condition, and 6 in 10 Americans seek mental health services but many cannot access them due to cost. To respond to issues found in Philadelphia and its surrounds, MHCS helps individuals, children and families from the community reach their greatest potential. With more than 150 full-time and part-time staff, and an annual operating budget of over \$8 million, MHCS serves an average of 2,600 individuals and families per year through the following programs:

Housing/Residential Services: MHCS has housing programs that encompass transitional and permanent housing that serve the Philadelphia community. MHCS is made up of eight different facilities, providing services to unhoused individuals and families. From the MHCS "Bridge House" which offers temporary transitional housing to residents in domestic, financial, or mental health crises; to Inglis Methodist Gardens, which provides affordable permanent housing, MHCS provides state-of-the-art housing and services for independent living. MHCS is proud to provide quality housing, in multiple ways, through permanent and transitional housing for women, youth and their families.



**Community Counseling:** MHCS provides counseling and psychiatric services to individuals, couples, and families in Bangor and Easton who are facing struggles in their daily functioning due to family conflicts, anxiety, depression, and other symptoms. Community Counseling Services helps clients utilize strengths-based strategies to manage distressing symptoms. In doing so, clients can improve day-to-day functioning and enjoy a reduction in symptoms such as anxiety, sadness and hopelessness.

**Education:** MHCS provides quality, licensed Kindergarten and early childhood services for children 6 weeks to 5 years old, including nutritious meals, and age-appropriate enriching activities. Head Start & PHL PreK Programs support families in Philadelphia with free childcare during the academic year to promote academic, social & physical development, while supporting families to fulfill their parental goals. MHCS also has multiple Out of School time programs and Summer Camps that provide additional enriching activities throughout the City of Philadelphia and on the main campus. MHCS' Heritage Farm grows fresh produce and offers hands-on education and life skills to the families that MHCS serves as well as to the surrounding community.



Case Management: MHCS' Case Management and Family Supportive Services provides support to families in need of stable housing, life skills, resources, and case management throughout the City of Philadelphia. The Parenting Collaborative teaches parents to understand and use positive parenting techniques and build healthy relationships with their children. MHCS' Community Schools Program and Case Management Services include a package of services and supports for students and families in four partner schools across Philadelphia. Family Unification Program and Shelter Plus Care support families that need help in securing housing throughout the city.

A distinguishing hallmark of MHCS is its client-centered approach and a strong commitment to fostering an environment where individuals feel valued. Consequently, MHCS is known by clients, staff, and external stakeholders (donors and partners) for its high-quality programs which have remained responsive and adaptable to the changing needs of the community. Clients report that they feel safe, welcomed, and respected by MHCS staff and that they feel more hopeful about their lives due to their connection to MHCS.

MHCS is currently led by three Boards, whose members have an impressive array of skills and backgrounds in corporate and nonprofit executive leadership, investment banking, accounting, higher education, medicine, nursing, mental health, child advocacy, restorative



justice, and church leadership. The Board has played a strong role in the organization's development, especially in supporting the executive leadership, and in providing strategic direction and financial oversight.

Other important partnerships include Mission First, Iron Stone, Quaker Group, Cradles to Crayons, PCOM, The Penn Towne Chapter of The Links, Foster Angels On Earth, The Junior League of Philadelphia, and even the Philadelphia 76ers.

As a result of MHCS' valuable and quality work, MHCS is seen favorably by funders and has had strong success in fundraising. In FY2023 MHCS raised \$7.3 million from donors and grants, (not including inkind donations from Methodist Church congregations and others) with 98% of this support coming from the government. This success in fundraising, together with a \$36 million endowment, which provides additional grants each year, resulted in an end-of-year surplus.

Those who know Methodist Services know it is a beacon of hope and high-quality support for vulnerable families and adults. Professionals and medical providers refer clients to Methodist frequently. Many donors are long-term supporters and partners across government, business, and nonprofit sectors who find great value in Methodist's work and approach to serving people in dignified and holistic ways. And most telling, clients report that the services they receive are high quality, they feel welcomed by staff, and are inspired to help others.
